SUBDIVISION & PUD APPLICATION

3. John Cahoon – Applicant is requesting a recommendation of minor plat approval for the Bray Amended Subdivision (4 lots) located at approximately 1940 North and Oakwood Place in a LR-F zone. (S-9-12)
4. Richard Cook – (Public Hearing) – Applicant is requesting a recommendation of schematic plan approval for a 112 unit town home project on approximately 8 acres of property located adjacent to the west end of Bourne Circle, north of the Farmington Fields Subdivision and east of US 89 in a LS zone. (S-12-12)

GENERAL PLAN & ZONING AMENDMENT APPLICATION

5. Richard Cook – (Public Hearing) – Applicant is requesting a recommendation to amend the City's Zoning Map by re-zoning approximately 8 acres of property located adjacent to the west end of Bourne Circle, north of the Farmington Fields Subdivision and east of US 89 from LS (Large Suburban) to CMU (Commercial Mixed-Use). (Z-3-12)

CONDITIONAL USE APPLICATION

6. Brad Pack – (Public Hearing) – Applicant is requesting a Conditional Use approval to allow the Sod fields of Pack Farms LLC, to be used for athletic use, primarily soccer during the grow in between planting and harvest of the sod fields located at approximately 1268 South 650 West (approximately 6 acres) in the LM&B zone. (C-12-12)
