SPECIAL ORDER OF FOREST SUPERVISOR  
UINTA-WASATCH-CACHE NATIONAL FOREST  
SALT LAKE RANGER DISTRICT

**ROAD CLOSURE**

**PROHIBITION:**

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System road described in this order. The road affected is located on the Salt Lake Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting November 9, 2016 until May 1, 2017 or until rescinded.

1. **Being in or upon the road** as described below and shown on attached map, with any motorized vehicle, except over snow vehicles (snowmobiles) and off-highway vehicles (ATV's, UTV's and Motorcycles). [36 CFR 261.54 (a)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIPTION:**

Starting at the Wasatch-Cache Forest Boundary, running east along the Farmington Canyon Road (Forest Road #80007) to the Bountiful Peak Campground located in, Township, 3 North, Range 1 West, Sections 7, 8, and 23; Township 3 North, Range 1 East, Sections 9,14,15,16, and 23, all within the Salt Lake Based Meridian and shown on attached map.

**PURPOSE:**

Purpose of the closure is to provide for public health and safety due to the road being steep, narrow with multiple switchbacks which should not be used in adverse weather or traveling conditions, where there is no winter maintenance (snow removal).

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
